It is proposed to fill up one post of Director (Finance & Administration) in General Central Service, Group 'A', Gazetted, Ministerial in the pay scale of Level-13, Rs. 118500-214100\* in the pay matrix and 5 post of Director(Technical Discipline) General Central Service, Group 'A', Gazetted, Non-Ministerial in the pay scale of Level-13A, Rs. 131100- 216600/- in the pay matrix on deputation (including short term contract) basis in National Rainfed Area Authority (NRAA).

2. **Eligibility Conditions of Director (Finance & Administration) :-** Deputation (Including short term contract) Officers under the Central Government or State Government or UTs or Universities or Recognized Research Institutions or Public Sector Undertakings or Semi-Government or Statutory or Autonomous Organizations:-

**(A) (i) Holding analogous posts on regular basis in the parent cadre or department; or**

- (ii) With five years' service in the grade rendered after appointment thereto on a regular basis in posts in Level-12, Rs. 78800-209200 of pay matrix or equivalent in the parent cadre or Department; or
- (iii) With ten years' service in the grade rendered after appointment thereto on a regular basis in the posts in Level-11, Rs. 67700-208700 of pay matrix or equivalent in the parent cadre or department; and

**(B) Possessing the following educational qualification and experience:**

- (i) Bachelor's degree from a recognized University;
- (ii) Twelve years' experience in the field of administration including five years experience in finance matters including budget and accounts.

**List of Duties/Responsibilities attached to the post of Director (Finance & Administration):-** Director (Finance & Administration) will assist Technical Experts & Chief Executive Officer (CEO) in Financial and Administrative matters.

**Regulation of pay:-** The pay of selected candidate will be regulated under the provisions contained in the DOP&T O.M. No. 6/8/2009-Estt. (Pay-II) dated 17/06/2010 as amended from time to time.

**Age limit:-** The maximum age limit for appointment by deputation (Including Short Term Contract) shall be not exceeding 56 years as on the closing date of receipt of applications.
