(4) The Director (Admn.), Directorate of Extension reserves the right to accept or reject any or all quotations without assigning any reasons thereof, and also reserves the right to split the quotation on L-1 basis and place orders for supply of items on lowest rate to one or more firms.

5. TERMS & CONDITIONS

- (i) The delivery of store shall have to be made to the Store-Keeper(Gr-I), Central Store at Offset Press, Street No.6 (Near FCI godown), **(Near Inder Puri side gate of IARI Campus)**, IARI, Pusa, New Delhi – 110012.
- (ii) The payment shall be made by cheque/e-payment after supply of specified stores in good condition along with "**Pre-receipted bill**" signed across a revenue stamp. It would normally take 10 to 15 days from the date of delivery of stores.
- (iii) Quotation received after the due date and time will not be entertained.
- (iv) Warranty of the lens may be indicated in the quotation letter.
- (v) VAT (if any) may be indicated clearly showing the %age of VAT, separately. In the absence of any indication to this effect it would be assumed that it has been included in the rate itself.
- (vi) The agency will have to replace the lens at no extra cost in case of any problem during warranty period.
